



## ENVIRONMENT ISSUES

### Neighbourhood Partnership Environment Forum

1. The Forum met on 14 April and discussed a range of matters - formal minutes will be issued later. The Environment Manager, Derek McGowan, has been seconded to the BOLD team and in the interim Andy Matheson will be our first port of call.
2. The proposals for funding of projects from the NP fund were firmed up. The budget is £67,500 to be shared with Craigentinny and Meadowbank CC. Those for Northfield and Willowbrae to be recommended to the NP on 2 June include:

## Baronscourt Park Survey Results 2015

### **Background**

During February and March I this year a survey of park was undertaken to provide information towards the production of a development plan for the park

The initial work was to produce a map showing the kind of things that could be done.

A survey was distributed in the community centre and library, sub-group meetings and via email. We received feedback from local residents via email letters and an open meeting was held by the community council.

Some residents suggested that there was no need for change however as the park requires to be used as part of the wellbeing and health needs of the local residents no change is not an option. It also must meet the council's agenda to promote health and well being.

### **Survey Results**

43 people responded to the survey so a big thank you to you all. The majority of the feedback to the proposals was positive.

### **Ball game provision**

It was claimed by some of the residents that part of the planning permission given for the park included a ban on all ball games. I am unable to find any such agreement and can advise that this clause is not shown in the original planning conditions.

### **Football pitch**

There was a strong vote for this although there was a split opinion as to whether it should be used by an official football team.

We will not be taking this venture any further at this time however a small set of goals will be provided for local residents

### **Bio diversity**

There was a strong opinion to increase the bio diversity within the park and this ties in with the Edinburgh Living Landscape proposals being introduced by the City of Edinburgh Council.

### **Grass cutting**

During last season's grass cutting we had a major problem with one of our ride on machines. This machine has been replaced and it is anticipated the appearance of the park will be improved this coming season.

Based on the responses the plan has been reviewed and some changes relating to the comments raised during the consultation have been addressed as follows:

- Reports of anti social behaviour are being investigated and we are working with Morrison's and the Community Safety Team to address these concerns.
- The Council Forestry Team is working on a management plan for the woodland areas in the park.
- The provision of a cycle track will not be introduced until the recommendations from the woodland management plan has been undertaken.
- The area of mixed grass and perennial flowers has been increased and soft fruit trees introduced into the plan.
- Flora will be added under and within the tree area
