Cycling

5. Gordon Macdonald reported that it had been difficult to re-establish links with the Council. The previous community council had been working on routes into N&W from the City, including one through Holyrood Park, which the Council had now put on hold.

Isolation

6. Sam Rutherford reported that a meeting had been held with experts from LOOPS (Local Opportunities for Older People) to examine ways of reaching with people who may have little social contact. A social event was being held in the Barrel House on 14 June as part of this work.

7. The Community Council <u>agreed</u> the report.

Treasurer's Report

8. The Treasurer reported that retained funds held by the City Council had been released together with a half-year grant for the current year. The total was £3735.50 made up of £3,347.06 returned and £388.44 new grant. One cheque for overtime hire for the community centre room had been paid.

9. The accounts were <u>agreed</u>.

10. Under the chairmanship of Bill Whyte the four office bearers were re-elected by a unanimous vote.

11. The Chair <u>closed</u> the AGM at 20.00
